TREASURER'S REPORT

As this article is being written, the Fin's Federal and State tax returns are being calculated. Our Accountant, Mike Pallein, usually makes some adjustments particularly for depreciation and equipment purchases. So I will present to the board and membership the return next month. The Fin had a great year in terms of finances. With the recruitment efforts and the state and zone shoot the club was able to bring in additional funds this year. I would like to reiterate what John Powelec says 'run a function we will have more funds'. Functions regardless of how small will bring in funds for us to make renovations and pay for our existing bills. Please if any of you have some ideas and energy, step forward and run an event.

There has been some discussion as to the how's and why's of mortgage payments. The Fin has three passbook (computer available) accounts and one checking account. On the monthly financial report the total of funds in these four accounts is reported on the balance sheet as cash. The passbook accounts receive moneys through transfers from the checking account. Members pay their dues and assessments at the bar and the funds are rung under their correct account but all the money goes into the checking account. For the funds to be put into one of the passbook accounts, it needs to be done and recorded as a transfer

from the checking to the respective account (this takes time and book keeping and reconciliation). During December and January when dues and assessments are coming in daily for about two months the checking account has lots of money. Sometime in the late winter and also in the early fall funds are transferred from the checking to the passbook accounts.

There are times during the year that the Fin does not bring in enough money to pay the bills. Money needs to be transferred from these passbook accounts into the checking to pay the bills. When a \$15,000+ insurance bill needs to be paid funds need to be transferred. When the taxes are due in the winter and summer funds need to be transferred. When an unexpected order of targets needs to be ordered or when 1000 birds die and need to be replaced funds need to be transferred. It is difficult to know when these things will happen so if money that should be transferred into the passbook accounts is spent the transfer can not happen until sufficient funds are available. It would be unrealistic to think that the club would or should use the passbook accounts as a checking account and transfer funds in and out weekly. By the end of the year (Sept 30), the passbook accounts are justified.

To set the record straight, finds from assessment 1 have paid for the Skeet Field loan and \$14,000 of maintenance

for this past year. The skeet field loan is paid at the end of each month and is \$1141.62 each month (\$13,699.44 each year for a three year total of \$41,098.32). No additional payments have been made on this loan. Funds collected for assessment 1 totaled \$65,000 over the last three years and currently has \$18,443.07 in it. As I said before several other maintenance projects have been paid from this account which adds to well over the \$5,458.61 difference between these numbers. The Ostrager land purchase is paid at the beginning of each month. This payment changes each month and we pay an additional principle payment each month. Three \$10,000 payments have been made to this loan sometime in the beginning of each year. The total principal paid on this loan is \$48,997.85 with a similar amount for interest. With the additional payments on the Ostrager loan, this loan is being paid off faster than the skeet field loan but the club is making good progress on both of these loans. The executive board members are discussing ways to make additional payments on the skeet field loan. They are currently negotiating the terms of the current loan with the Savings Institute.

I hope this explanation is helpful in explaining how the loans are being paid.


