TREASURER'S REPORT

Here we go again; it is time for the newsletter and another treasurer's report. Each month at the meetings we discuss that the Fin is responsible for two large loans. One loan allowed us to purchase a large piece of land bordering the Fin and is payable to Murray Ostrager. The other loan is with The Savings Institute and it allowed us to renovate our skeet and trap fields. Ostrager's loan has \$32,000 left to pay; we currently make a double payment each month which is about \$1,100 in principal and ~\$200 in interest. At this rate, this loan will be paid off in less than two years. The other loan is much larger and we send a check for -\$1,700 each month with -\$925 going to the principal and ~\$700 towards interest. This loan will be paid off in about nine years. Everyone hates owing money but without these loans the Fin would not have been able to purchase the land or make renovations. So, we have to deal with the payments and interest to be able to enjoy the club. The holidays are coming soon and I wish everyone good tidings and joy. Please come to the club and partake in the festivities. As always, if you have an idea that can make money while we enjoy ourselves, please let us know
