TREASURER'S REPORT

As I sit down to write this report, I am in a warm building trying to avoid the single digit temperatures of our wonderful Connecticut weather. I have been trying to train my dogs (maybe training a Lab is impossible) these past few weeks. The plastic bumpers are frozen solid and they get covered with frozen snow and saliva, not so inviting for a dog. Earlier this morning I was at the Fin with my dogs; so much fun watching the dogs run and investigate the surroundings. The sun was shining and the asphalt was warm so I set up a drill on the parking lot for them. I could not work my dogs like this if the Fin was not here. The money and hard work of all the members makes it possible for me to do things that I enjoy and would not otherwise be able to do.

To make the club as nice as it is, we have had to borrow money. As anyone with a mortgage knows, the negative side of borrowing money is paying it back. The skeet and trap fields are as good as any around. As many of you know, we have a variable rate loan for the skeet fields from the Savings Institute in Willimantic and we recently negotiated it to a 6.5% variable loan for the remaining \$130,000. The Executive Board has authorized me, as Treasurer, to pay an additional principal payment each month to reduce the total amount of interest that we need to pay. Our payments will be ~\$1,400 per month. The Fin has a separate loan that allowed us to purchase ~22 acres that were located adjacent to our property. Our strategy here has been to pay an additional monthly principal payment for this loan as well. At present, our monthly payment is ~\$1,200 and we still owe ~\$70,000.

Our President has asked if our accounts should be reviewed by a committee of individuals from the general membership. I strongly support this idea. Keeping the accounts of an organization like ours is very important and it benefits all of us to have critical eyes reviewing our procedures. Jon Guarino, former Treasurer for several years, has been very helpful in keeping the system consistent. The Fin's books have been kept in a similar manner for over six years and this facilitates understanding, but review from a committee of members is prudent. Anyone interested in serving on this review committee should contact President.

Finally, I indicated in the last newsletter that our accountant, Mike Pallien (a member), was preparing our federal and state tax returns. We paid \$63 to the federal government and \$1388 to the State of Connecticut. The financial standing of the club is solid for another year, however, to maintain good fiscal health we need to keep the membership strong (~400 members) and conduct fund raisers. I urge everyone to think of some new or reworked functions they would be willing to run; steak dinners are especially successful. I am sure that all of you can think of something that would raise money. Please come to the Executive Board with your ideas.

SURVEY UPDATE

Thanks to all who returned your membership surveys, we received 174 completed surveys this year versus 175 last year. It has come to my attention we overlooked Life Members in distributing the survey as they do not receive the December mailings for membership renewals. Please be assured that we will forward surveys to this important segment of our membership in the future.

To date, we have compiled approximately one-half of the responses and will be contacting those folks that volunteered to participate in the planning activities associated with this activity. We anticipate publishing full survey results in the June newsletter.

The survey results carry significant weight when the board develops the 2007 expenditure plan. Many members participated in the implementation of recommendations that resulted from last year's input and have witnessed the substantial improvements to the pheasant facility and Clubhouse. We still have many improvements that need to be implemented and will continue to do so as our finances permit.

FISH NEWS *J. Guarino*

It is that time of year again to think about the ice melting and throwing a line in one of the Fin's ponds. The first stocking will occur right after the ice is gone, about April 1st. An email notice will be sent immediately before each stocking. After the initial stocking is done we will follow that up with two more stockings on April 13th and May 4th. All of the rules from last year remain the same. The fly pond will remain no-kill from the first stocking to the end of the Kid's Derby on May 6th. From May 6th to the Friday before Memorial Day the fly pond will remain fly fishing only, at that point it will be open to all fishing. Fly fishing will also be allowed in the middle pond.

Please handle fish gently. If you intend to release them bend your barbs down. The fishing rules will be posted at the sign-in boxes at each pond. Please sign in and be sure to read and understand the rules.

We hope to resurface the docks at the fly pond. A member that worked at a building materials distributor approached me last year and offered material at reduced cost. Unfortunately I am not good at remembering names and if that member would contact me again I would appreciate it. We also need a couple of volunteers to help with the fly casting clinic at the Junior's Day on May 5th, please contact me if you can help for part of or the whole day. PISTOL NEWS *Dick Palmer*

Hey shooters, the Summer Pistol League will start Wednesday April 25th and will continue through September 5th. Matches start at 6 pm. So dust them off, start dry firing, and see you all on the 25th of April.

On April 14th, weather-permitting, there will be a short clean-up at the range. This will involve removing leaves, raking the banks even, and pruning some brush. This work activity will start at 10 am and be completed within 1 to 2 hours. Look for an article by Fred Vernic that will outline the start of a Saturday morning shoot, basically the same as Wednesday nights but will not use the 50 yd line of fire. Until the next time "Keep 'em in the ten range".

RIFLE NEWS *Peter Mathewson*

There will be 5 "Across-the-Course" matches at the FFF this year. These will occur on April 29th, May 27th, June 17th, July 15th, and September 6th. There are 50 rounds per match at 200 yards.

The Annual D-Day Garand Match will occur on June 3rd. This involves 30 rounds with ammunition provided. M1 Garands only; the cost is \$15/shooter.

For all Matches, registration is at 8:00 am and shooting starts at 9:00 a.m.



ATTENTION TURKEY HUNTERS, RIFLE, PISTOL AND SHOTGUN SHOOTERS

Due to the Juniors Outdoor Weekend on May 5th & 6th, the following restrictions are being implemented to insure the safety of all concerned.

On Saturday May 5th :

- (1) There will be no Turkey Hunting allowed on the Clubhouse side of Chewink Rd.
- (2) The Rifle Range and Pistol Range will be closed for Youth Clinics.
- (3) The Skeet Fields will remain open but Field 6 is reserved for a Youth Clinic.
Shotgun shooters are asked to use fields distant from #6.

During the Kid's Fishing Derby all ranges are closed until 12:00 noon.

ARMBANDS 2007

This year, Armbands will be mandatory for all members hunting club-owned and club-leased property. This will include Deer, Turkey, Waterfowl, Pheasant and Upland Small Game.

Written consent forms will only be issued to members in good standing who have purchased an armband for the 2007 calendar year. Armbands and consent forms will be available for pick-up at the same time. In an effort to make things easier for everyone we will no longer have the pheasant hunting group applications. When you purchase your 2007 armband at the clubhouse, just tell the bartender which group you wish to hunt with (Group A, B, or Wed.) and he/she will issue the armband and assign you to the specific group. The cost for a 2007 armband is \$10 and may only be purchased at the bar during regular bar hours from April through December 2007.

FFF CLUB 2007 'JUNIORS' TURKEY & DEER HUNTING

Our Club will once again offer you the opportunity to provide a Junior Hunter with a Turkey and Deer Hunting hunting experience on the state-sponsored Junior Hunter Training Days. The Junior Hunter needs to be a Son/Daughter, Grandchild, or Niece/Nephew of a regular club member, 12 to 15 years of age and a licensed hunter with the appropriate tags.

These training days provide an excellent opportunity to start our young hunters off with a great hunt. They occur on a day prior to the regular season opening when no pressure has yet been experienced by the game. This enhances the Junior Hunters' chances for success. It's Opening Day just for kids!

The dates for the 2007 Junior Turkey and Deer Hunter Training Days are:

Turkey – Saturday April 28th, 2007

Deer – Saturday November 10th, 2007

In order to participate, the following requirements must be met:

- 1) The Junior Hunter and the Adult Mentor must each have Private Land Spring Season Turkey and/or Private Land shotgun/rifle Deer Permits (shotgun only may be used). Apply through DEP.
- 2) The Junior Hunter and the Adult Mentor must each have written consent forms signed by the landowner. Apply for your consent forms through the club.
- 3) The Junior Hunter must be either a Junior Member of the club or a relative of a club member. FFF Junior Members' consent forms will be valid for the year. If the Junior Hunter you take out is not a club member then the consent form will only be valid for two days - April 29th and Nov 11th.
- 4) Adult Mentors must be Club members, at least 21 yrs. old and may not carry a firearm.
- 5) All other applicable State laws and FFF Club rules apply. Please consult the 2007 Connecticut Hunting and Trapping Guide.

REGISTERED SKEET PROGRAM – 2007

The Fin will be sponsoring several registered skeet shoots in 2007. These will be smaller in size than those hosted last year. In 2006, the Fin hosted both the Zone 1 shoot and the Connecticut State shoot. The former involved shooters from all of the New England states and those from New York. The vast majority of the more than 100 shooters who participated in the event were favorably impressed by the Fin and its facility. The state shoot was a bit smaller since only state residents could participate but still more than 60 attended. The success of these shoots was due largely to the Fin members who worked during the shoots. They can take justifiable pride in a job well done as the financial reward to the Fin from these two shoots and our own NEOPEN shoot held in June was excellent and much needed.



This year we again will hold our NEOPEN shoot on the weekend of June 1, 2 & 3. The shoot will involve 5 different events of 100 targets each. They are: Doubles, 12 Ga., 20 Ga., 28 Ga. and the .410. The afternoon of Friday June 1st will be the Doubles event. Saturday June 2nd will see the 20 and 28 Ga. events and then on Sunday the 3rd we will finish up with the 12 Ga. and lastly the .410. We anticipate a large turnout of shooters and will require a good deal of help from the Fin's membership. Individuals are needed all three days to load targets onto the trap machines, to clean the houses of broken targets and empty boxes, to sweep the walkways on the fields, to collect spent hulls from the fields and to provide assistance to the shooters. We always have water available on each field and it must be replenished throughout each day. There is always some job that needs doing and having enough personnel available to do all of them makes life easier for those who run the shoots. We have a practice field available and we need members to man the field, load the machines, pull targets and generally be a resource to those practicing since many will be non-members. Our field kitchen will be open all day Saturday and Sunday. Help is needed to transport food, ice, soda, coffee and other items. We need people to empty the garbage and generally just be around for performing small tasks and errands.

We also need registered referees. Some members are already experienced and have refereed in years past. They need to re-take the referee test. Any new members who wish to learn to referee are most welcome. Practice sessions can be arranged at their convenience. The Fin saves alot of money when it does not have to pay referees and that money reverts to our treasury as profit!

On Sunday July 15th, the Fin will have a one-day shoot called the Fin Open with events in the 12 and 20 Gauges. This will be an easier shoot to manage since it will be much smaller than the one in June. If there is enough interest (i.e., help) we could make this a 2-day shoot thus improving our income. Let me know!

On Sunday August 5th, the Fin will host a 1-day shoot, the No Name Open. Again, the events will be the 12 and 20 gauges. We also have the option to make this a 2-day shoot if sufficient help is available.

Anyone who wishes to help as a referee or in any other capacity at the shoots should call Frank Mauri (860-974-1425) as soon as possible so that they can be assigned times to help at each particular shoot or times to learn the tasks of a referee.

Currently the club has 393 Regular members. There were 25 Regular & 4 Associate members that dropped out of the club or did not pay their dues for 2007.

The good news is that our current membership numbers are the most that we have had at this time of year in quite a while. Last year was a good one for new members, a total of 46 Regular and 9 Associate members joined the club. The club continues to bill those members who do not fulfill their 10 hour work requirement. As a result, the club collected \$13,330 this past year. This amount is the most ever collected for a single year. Since 2001, over \$59,000 has been collected from uncompleted work hours.
